It was moved by MWGM Spencer Scott (SC) and seconded by MWGM Joe R. Gonzalez (MN) that the proposed Agenda be adopted. The motion carried.

WELCOME and RESPONSE

Greetings and Welcome from Past President MWPGM John M. Bettis (NJ). MWGM Emanuel J. Stanley (MD) gave the response to the Welcome.

RECOGNITION OF VISITORS

MWPGM Dorian R. Glover (NY) introduced the following guest:

Most Excellent Grand Master General Bobby R. Thompson Jr., Knights of York Cross Honor PHA, Convent General, USA brought greeting.

Hon. Charles W. Davenport, Imperial Potentate, AEAONMS, North & South America and its' Jurisdiction, Inc. The Hon. Charles W. Davenport brought greetings.

MWPGM Dorian R. Glover spoke on the turbulence between Florida and Louisiana. He also stated that he did not invite anyone outside of the Grand Masters to this year's Conference. He stated that the Grand Masters have work to do.

COMMITTEE APOINTMENTS

The Committee Appointments were read by MWPGM Dorian R. Glover (NY) and updated by the Executive Secretary Fred Way Jr. (DE).

MWGM Quincy Gant (DC) thanked the President for his remarks on the Elephant in the room.

MWPGM Philip David (DC) brought greetings. He discussed the online portal.

SPECIAL REPORT

MWGM Walter Gulley, Jr. (FL) gave review as to stated what happened at the Special Communication for the conference of Grand Masters in November 2018.

MWGM Ralph Slaughter (LA) stated he would withdraw the Lodge and Chapter in Panama City, Fl. He has done that. MWGM Walter Gulley (FL) stated that although MWGM Ralph Slaughter (LA) withdrew the Lodge and Chapter they continue to do masonic work in Panama City. MWGM Walter Gulley (FL) stated that the removal of recognition from (LA) was based on what happened in the Virgin Islands in 2015.

This prompt an intense dialogue between several Grand Masters. MWGM Slaughter (LA) stated that he will leave the meeting rather than be treated as he perceived to be.

MWPGM Dorian R. Glover (NY) stated that MWGM Florida was being nonresponsive. MWGM Ralph Slaughter (LA) stated that he has no problem with Florida not recognizing LA. He and MWGM Kelvin Davis (OH) asked MWGM Walter Gulley (FL) to stay in the meeting.

A discussion on allowing the Grand Lodge of the Virgin Islands to have a seat at the table. MWPGM John Bettis (NJ) stated that it was thought by some that the forming of the Virgin Islands Grand Lodge was irregular.

WHITE PAPERS

South East Region White Paper was presented by MWPGM Dorian R. Glover (NY).

The report recommended that the Virgin Island Grand Lodge gets reformed. MWGM Ralph Slaughter (LA) gave a history of what happened in the Virgin Island in the formation of the Grand Lodge, and he stated that (LA) had two Lodges in the Virgin Islands and they were not Virtual regardless of what the Policy and Procedure Committee stated.

There was then a discussion between MWGM Kelvin Davis (OH), MWGM Ralph Slaughter (LA), MWGM Walter Gulley (FL).

MWPGM Dorian R. Glover (NY) sent the issue to the Historical and the Policy and Procedures Committees; to come together to address the issue of the Virgin Islands.

MWPGM Dorian R. Glover (NY) met with the MWGM of the Prince Hall Grand Lodge of France. They have 38 Grand Lodges in France. MWGM DT Thompson (NC) gave a history of the Prince Hall Grand Lodge of France. MWGM Daniel (DT) Thompson (NC) stated that he believes Prince Hall Grand Lodge of France is a regular Grand Lodge.

MWPGM Dorian R. Glover (NY) stated the MWGM Bruce James (GA) was involved in a Fishing Accident and could not make it to the conference. MWGM Richard Vega (NV) gave a prayer for all that could not make it and wanted to make it to the conference.

The conference went from Labor to refreshment at 10:35 am.

The conference went from Refreshment to Labor at 10:50 am.

MWGM Spencer Scott (SC) gave remarks. He stated that there was a convention for the Royal and Select held in South Carolina. Several Grand Masters attended. The Grand Master stated that all Grand Masters should let the host Grand Master know if you intend to come to their Jurisdictions.

It was moved by MWPGM John M. Bettis (NJ) that the remarks be received and sent to the Protocol Committee. IT was seconded by many. MWGM Edward C. Mitchell, Sr. stated that this is already a part of the Protocol. The motion passed.

MWPGM Dorian R. Glover (NY) apologized to MWGM Walter Gulley (FL) if his tone and presentation this morning was offensive.

MWPGM Dorian R. Glover (NY) asked the Grand Secretary of Liberia to speak on the Congo situation.

RW Wil Freeman, the Grand Secretary of Liberia stated that another Grand Lodge in the same territory would not be recognized. He hopes this Conference rejects the application from the Congo. The Grand Secretary and MWGM Daniel (DT) Thompson had a conversation that concluded with a way forward to work out how to form a Prince Hall Grand Lodge in the Congo that could be recognized by this committee/conference and the existing African Grand Lodges won't feel infringed upon. MWGM Quincy G. Grant (DC) asked what is our relationship with the Conference of Grand Masters of Regular Lodges of Africa? It was stated that we do have a relationship with them. The issue with the Congo will go to the Fraternal Relations Committee.

MWPGM Dorian R. Glover stated that an Ad Hoc committee is going to take the issue of the Grand Masters not being regaled as Grand Masters at the Shrine Convention is disrespectful. MWPGM Henry Willis (MO) stated that he definitely feels that this is an issue that needs to be addressed by this body. MWGM Walter Gulley (FL) stated that when the COGM met in Arizona, and Illustrious Potentate Parks stated that Shrinedom is not a part of Prince Hall Masons. Why do we invite the Shrine to this meeting?

MWGM Jeffrey M. Calcote, Sr. (WV) asked what if the host is not a noble, how would he be regales and will he be invited to the Imperial Session? MWGM Quincy G. Grant (DC) stated that we invite the Nobles to our annual sessions, and they come dressed as Nobles.

MWPGM Willie L. Williams (GA) stated that we withdrew recognition from the Shrine in 2008, why are they still invited? MWPGM Dorian R. Glover (NY) stated that the conference needs to make a decision on how we want to move forward with the Shrine.

The Imperial Potentate Charles W. Davenport stated that everyone who comes, come dressed as a Noble if a Noble. All Non-Noble dignitaries will be dressed in black suits. PMWGM Henry Willis (MO) stated that a resolution allowing the sitting Grand Master of the Host Jurisdiction to come to the Imperial Session styled as a Grand Master has already been submitted to the Imperial Council.

MWGM Edward C. Mitchell Sr. (NM) brought comments from the Phylaxis Society.
Eminent Grand Master Samuel Davis brought greetings.

MWGM Vega gave a closing prayer at 12:00 Noon and the Conference was called off for the day.

MEMORIAL SERVICE

The Memorial Service began at 9:10 AM with Past Master Vaughn O. Jones, RW Recording Grand Secretary (Bahamas) serving as the Master of Ceremonies.

PGM Jane S. Hutcheson Worshipful Grand Master of Ceremony, Most Excellent Grand High Priest (Bahamas) gave the invocation. The scripture was given by PMG Terrance Cartwright, Sr. RW District Deputy Grand Master, District 7A&B South Andros (Bahamas). The Litany was led by Sister Theresa O'Bridgewater Past Matron, PHGC, OES (Bahamas). Next was the Opening Hymn "Through All the Changing Scenes of Life".

The roll call of deceased members of the Conference of Grand Matrons and Grand Patrons and the Conference of Grand Masters was rendered by Sister H. Lorraine Jeter (PGWM, Executive Secretary, Conference of Grand Worthy Matrons and Grand Worthy Patrons) and PGM Fred Way, Jr. (DE) respectively with each Jurisdiction placing one rose in the Vase representing the deceased Sisters and Brothers from their Jurisdiction.

The introduction of the speaker was done by PM Uriel Johnson, RWDD Grand Master, District No. 1, Nassau (Bahamas). This was followed by a musical selection by Bro. Eugene Williamson, Grand Organist MWPHGL Bahamas. The Morning Message and the closing prayer was delivered by Bro. Rev. Tragean Jadorette. This was followed by the Closing Hymn, "Abide with Me".

The Joint Memorial Service was called at 10:20 AM.

JOINT OPENING CEREMONY

The Joint Opening Ceremony began at 10:35 AM with PGM Edison Dames, President William Watson Thompson, Past Grand Masters Council PHA Bahamas, serving as the Master of Ceremonies. A medley of Sacred Music was followed by the Invocation which was given by Bro. Bishop Delton Fernander, President, Bahamas Christian Council.

Next was the postings of the colors by the Royal Bahamas Defense Force. The National Anthems of the Bahamas (March on Bahamaland), Liberia, Barbados, Canada (O Canada!) and America (The Star-Spangled Banner) was rendered by the congregation.
